Hull, president of Hydraulic Wells Secretary of the Constantine Hydraulic Company proprietors, have caused the land embraced in the annexed plat to be surveyed, laid out, & platted to be known as the Hydraulic Company's ADDITION to the VILLAGE of CONSTANTINE that the streets & alleys as shown on said plat are hereby dedicated to the use of the public.

The land embraced in the annexed plat of the Hydraulic Company's Addition to the Village of Constantine, is described as follows: Commencing at a point 350 feet west & 269 feet north of the east quarter post of Section 23 Town 7 South, Range 12 West, thence north 35° west 400 feet to margin of reservoir, thence along said margin north 59° east 50 feet, thence south 80° east 65 feet, thence south 89° east 63 feet, thence north 81° east 58 feet, thence north 58° east 49 feet, thence north two degrees east 124 feet to the northeast line of this land, thence south 75° east 402 feet, thence south 62° 30' west 93 feet, thence south 15° east 246 feet, thence south 70° east 66 feet, thence south 20° 30' west 193 feet to the place of beginning.

Thereby certifying that the plat hereto delineated is a correct one and that permanent monuments consisting of stone trees & stakes have been placed at points of angles & as shown at all angles in the boundaries of the land platted and at all intersections of streets or alleys -

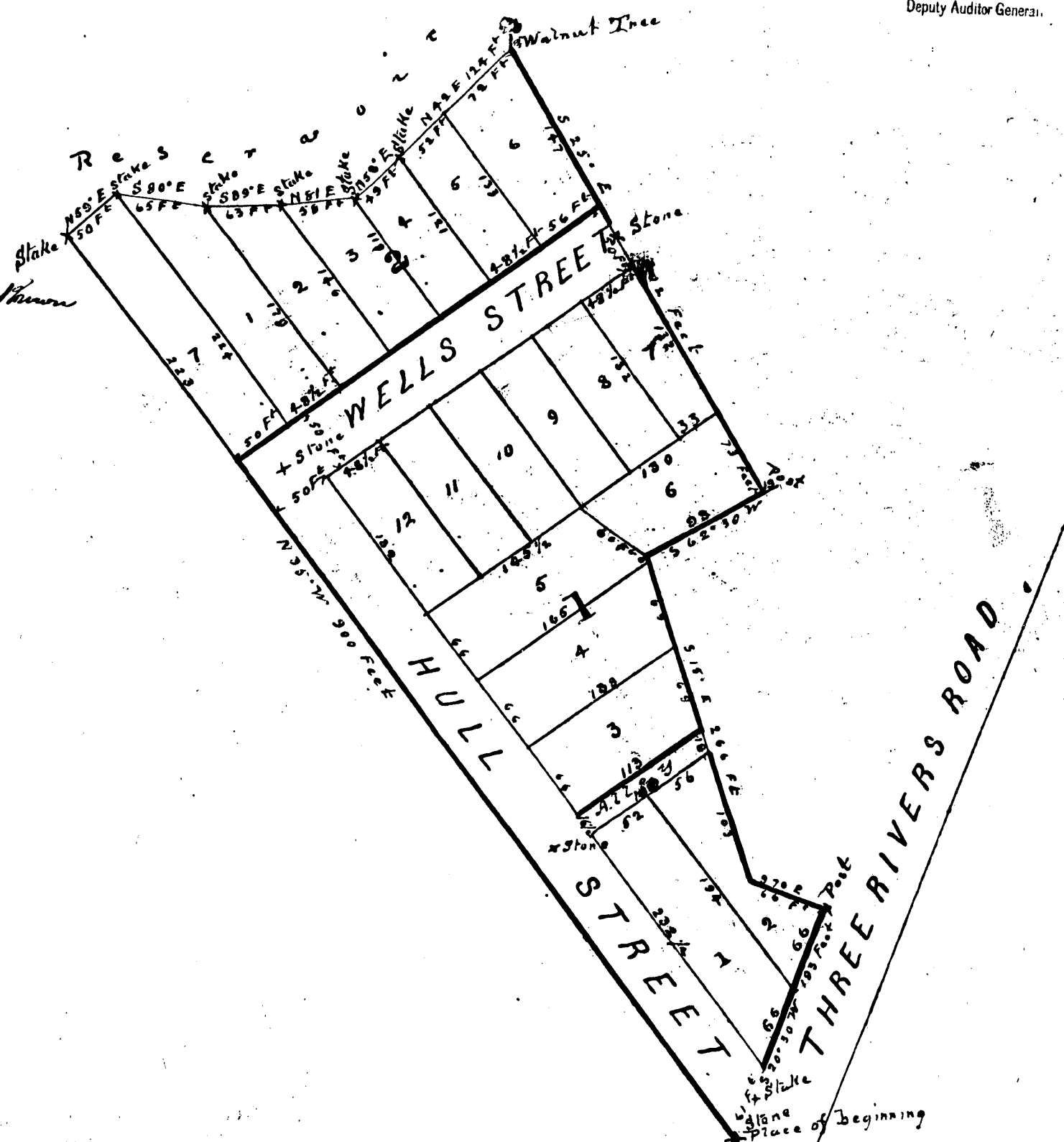

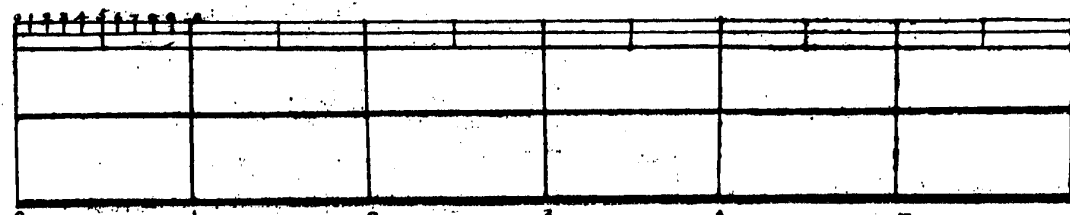
