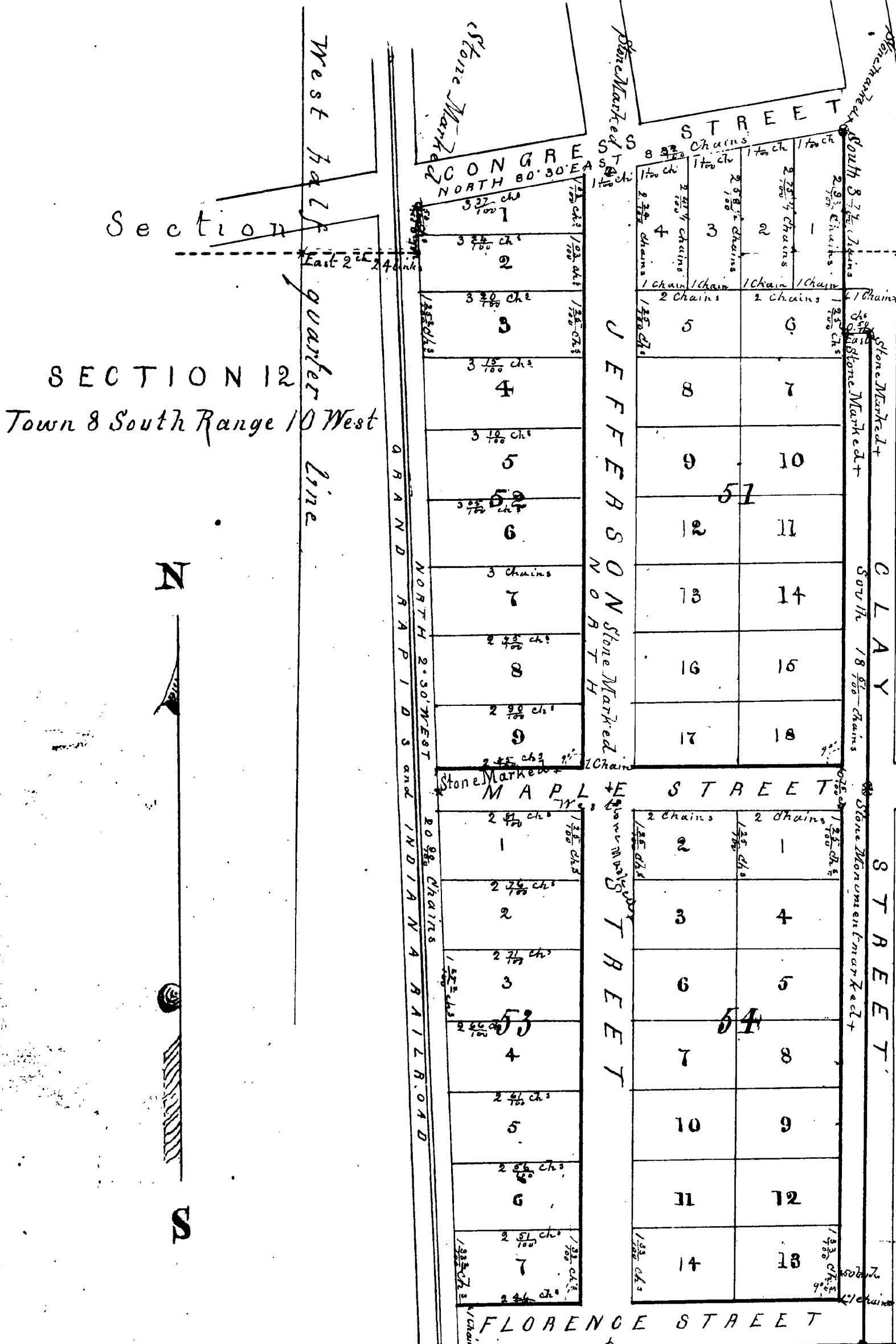

BUNNELL'S ADDITION
to the Village of **STURGIS**

Bunnell's Addition to the Village of Sturgis St. Joseph County Michigan is located on the southeast quarter of the southwest quarter of Sec. 12, T. 8 S., R. 10 W., and on the west half of the east half of the north west quarter of Section twelve, T. 8 S., R. 10 W., and is bounded as follows - Commencing at a point seven and five eighths north of the section line between sections one and twelve aforesaid and two chains and twenty four links east of the southeast corner of said southwest quarter of the southwest quarter of Section one aforesaid. Running thence north 80 degrees 30 minutes east 8 7/8 chains thence south 3 7/8 chains thence east 50 links, thence south 18 7/8 chains, thence west 7 7/8 chains to a point on the ground marked and described as the southeast corner of the north 2 degrees 30 minutes west along said east line 20 7/8 chains to the place of beginning. The width and length of all lots and streets are fully described in figures according to law. All streets run north and south and east and west and are at right angles to each other and are hereby dedicated to the use of the public. Witness our hands and seals this 16th day of December 1887
