MARCH SESSION MARCH 21, 2006

Regular Session of the Board of County Commissioners for the County of St. Joseph, State of Michigan, was held in the Commissioners' Room, Courthouse at the Village of Centreville, Michigan on March 21, 2006, at 5:00 p.m.

Chairman Bordner called the meeting to order.

The Invocation was given by Commissioner Pueschel.

The Pledge to the American Flag was given.

The Clerk, Pattie S. Bender, called the roll and the following Commissioners were present:

AGENDA

Ms. West-Wing asked that after the second citizens' comments that a closed session be added for the purpose of property acquisition.

It was moved by Commissioner Dobberteen and supported by Commissioner Dunlap that the agenda be approved as amended. Motion carried.

MINUTES APPROVED

It was moved by Commissioner Dobberteen and supported by Commissioner Shafer that the minutes for March 7, 2006 be approved. Motion carried.

CITIZENS' COMMENTS

Ray Cox, 25786 Rainbow Drive, Sturgis - Sand Lake - addressed concerns that he has regarding the dam on Lake Templene. He is concerned that residents of Sand Lake may pay assessments on the dam on Lake Templene if the dam is purchased.

Jack Rote, 61996 Bayshore Drive, Sturgis - Lake Templene - stated that he is representing the residents of Lake Templene. He referred to the Inland Lake Level Act regarding the County's obligation to inspect all dams in the County. He says that the property owners on Lake Templene have no dispute with a special assessment district being established to maintain the dam and as a result maintaining the lake level as required by court order. Their concern is that they do not believe that the County needs to purchase the dam and pass the assessment along to the assessment district.

Except for the last inspection of this dam there were no problems with the County inspecting the dam since 1970. He believes that that sets a precedent and they contest the County purchasing the dam. He further stated that in the 1970s there was a court order setting the lake level and the Drain Commissioner oversees all lake levels as ordered by the Court.

On July 1, 2004 there was a hearing in Circuit Court on the Special Assessment District stating that everyone affected should pay. They have recently requested a copy of the court transcript of that hearing.

The presiding Judge ordered the Drain Commissioner to acquire the dam and the court cannot mandate that the County own the dam.

Patricia Parker, 25700 Rainbow Drive, Sturgis - Sand Lake - stated that she is protesting any special assessment to property owners on Sand Lake.

LEASE RENEWAL WITH THE ECONOMIC DEVELOPMENT CORPORATION

Ms. West-Wing recommended approval of a lease renewal for the EDC at Annex II for 1 year at \$8.69 per square foot per year.

It was moved by Commissioner Dobberteen and supported by Commissioner Pueschel that the lease renewal with the EDC be approved.
