

**St. Joseph County Notice of Public Hearing to Adopt a Brownfield Plan Amendment
Tuesday, December 15, 2020**

NOTICE OF PUBLIC HEARING ON THE ADOPTION OF A BROWNFIELD PLAN AMENDMENT FOR THE COUNTY OF ST. JOSEPH, PURSUANT TO AND IN ACCORDANCE WITH ACT 381 OF THE PUBLIC ACTS OF THE STATE OF MICHIGAN OF 1996, AS AMENDED.

PLEASE TAKE NOTICE THAT a Public Hearing shall be held before the St. Joseph County Commission on Tuesday, December 15, 2020 via Zoom on the adoption of a Brownfield Plan Amendment for property at 32469 US-12 and an adjacent vacant parcel, Burr Oak Township, Michigan, parcels 75-001-035-005-02 and 75-001-035-005-03.

The proposed Brownfield Plan Amendment would allow the developer, Midwest V, LLC to be reimbursed from tax increment revenues for eligible activity costs incurred to prepare the brownfield property for redevelopment, as defined under Act 381. The property description, maps, and the proposed Brownfield Plan Amendment are available for public inspection at www.stjosephcountymi.org and in the County Administrator's Office. All aspects of the Brownfield Plan Amendment are open for discussion at the public hearing.

The Brownfield Plan Amendment has been approved by the St. Joseph County Brownfield Redevelopment Authority with Burr Oak Township's concurrence. The public hearing is an opportunity for citizens and taxing jurisdictions to learn about the project and voice their concerns. After the public hearing, the St. Joseph County Commission will consider final approval of the Brownfield Plan Amendment.
